The present application has been filed seeking interim ball of the accused Gurpreet Singh S/o Gurmeet Singh for 15 days on medical ground / humanitarian grounds.

On behalf of the applicant/ accused, it is submitted that vide order dated 10.09.2021 wherein this Hon'ble Court was pleased to dismiss the interim bail application of the applicant namely. Gurpreet Singh which was filed on medical grounds. The applicant had approached this Hon'ble Court as well as Hon'ble Sessions Court, bail application on the ground of non-filing of the complete charge-sheet and the same was also dismissed by this Hon'ble Court as well as Hon'ble Sessions Court. Applicant/accused is suffering from the history of medical illness i.e. 'piles' and for that the medical treatment was required which was not possible inside the jail under the custody of jail authorities. Applicant/accused was taken to Deen Dayal Hospital, Hari Nagar, Delhi on 31 12 2021 as his medical condition got deteriorated and the proper treatment is required which is not possible inside the jail premises. It is submitted that for the cure of the said illness, the laser operation is required and also the proper diet and care are required. It is submitted that applicant has no criminal antecedents except this present case and furthermore, the family of the applicant is totally dependent upon him as he has the liability of his wife namely Daljeet Kaur and two minor children aged 5 and 6 years respectively. It is submitted that accused shall abide by all the conditions of the bail while granting him ball.

I d. APP for the State has opposed the bail application submitting that applicant was arrested on 08.08.2021 and charge sheet was filed on 01.10.2021. There is every possibility that some more account in take name of accused could be found. He has also opened account in other bank also on take name. He used to change his name

and address. There is every possibility that he can jump the ball Heard. Porused

The fact that accused is being treated by jail authorities for medical ailment (piles). The accused wish to get him treated through laser operation at some hospital of his choice. Accordingly, considering the said fact for the sake of his health, the present accused is admitted to 15 days interim bail on furnishing of Personal Bond in the sum of Rs. 50,000/, with one surety of the like amount for the purpose of laser operation as pleaded by id. Counsel on his behalf subject to following conditions.

- 1 that accused shall get this operation done within 15 days:
- 2 that accused shall not seek further extension of interim bail.
- that accused shall be in touch with the IO and shall contact with him through telephone everyday;
- 4 that accused shall not temper any evidence or influence any witness,
- 5 that accused shall provide his mobile number to the IO and also his place of residence.
- 6. that accused shall surrender on the expiry of 15 days from the date of his release.

Application disposed off.
